### **Operational Rules and Practices**

1. Prior permission with estimated time of arrival is required for each flight to JL Bar Ranch & Resort Airport by calling one of the staff below or by email airport@jlbar.com.

2. The Airport release and indemnification agreement within the airport use forms on our website www.ilbar.com/airport must be completed prior to arrival.

- The electronic release and indemnification document is aircraft specific. As such, it will
  cover multiple landings for the Aircraft during the current calendar year. The JL Bar Ranch
  Airport will need to be notified prior to each arrival and departure. If the owner/operator
  would like to land a different aircraft, you will need to complete a new agreement covering
  that specific aircraft.
- Airport release and indemnification agreement is valid for the current calendar year. A new release will need to be completed post January 1 of the following calendar year.
- **3.** Please contact Unicom prior to landing and use standard uncontrolled airport radio procedures.
- **4.** All Jets and Large Turboprops please utilize teardrops at end of each runway for turn around.
- **5.** After landing, please contact Unicom or follow marshaling instructions for parking.
- 6. Please ensure your aircraft is properly secured with chocks or tie downs. Chocks are available and tie downs are marked on the east side of the ramp. JL Bar Ranch & Resort Airport staff will be happy to assist with securing aircraft. *Please use caution! Though it may not appear, the ramp is sloped.*
- **7.** Please provide JL Bar Ranch airport staff with your contact information, the intended date and time of departure prior to leaving the airport facilities.
